NOTICE

Lynn Jenkins Kansas Trust is a joint fundraising committee composed of:

Lynn Jenkins For Congress, the Republican National Committee, and the National Republican Congressional Committee (each individually, a “Committee” and collectively, the “Committees”).

Any contributions to **Lynn Jenkins Kansas Trust** permissible under the Federal Election Campaign Act, as amended (“FECA”), 2 U.S.C. §§ 431 *et seq.*, from donors who have not exceeded their applicable Federal contribution limits shall be allocated among the participating committees pursuant to the FECA and the following method:

1. The first \$2,300 from any single individual’s contribution shall go to the Lynn Jenkins For Congress General Election Account. The next \$28,500 from any single individual’s contribution shall go to the Republican National Committee. The next \$28,500 from any single individual’s contribution shall go to the National Republican Congressional Committee.
2. The first \$4,600 from any joint contribution shall go to the Lynn Jenkins For Congress General Election Account. The next \$57,000 from any joint contribution shall go to the Republican National Committee. The next \$57,000 from any joint contribution shall go to the National Republican Congressional Committee.
3. The first \$2,300 from any federal non-multicandidate PAC’s contribution shall go to the Lynn Jenkins For Congress General Election Account. The next \$28,500 from any federal non-multicandidate PAC’s contribution shall go to the Republican National Committee. The next \$28,500 from any federal non-multicandidate PAC’s contribution shall go to the National Republican Congressional Committee.
4. The first \$5,000 from any federal multicandidate PAC’s contribution shall go to the Lynn Jenkins For Congress General Election Account. The next \$15,000 from any federal multicandidate PAC’s contribution shall go to the Republican National Committee. The next \$15,000 from any federal multicandidate PAC’s contribution shall go to the National Republican Congressional Committee.

The contributor’s signature below shall constitute a written designation of his or

her contribution to particular elections as described above.

All contributions permissible under the FECA but that would cause a contributor to exceed any applicable Federal contribution limit to a specific committee, shall be reallocated to the other Committee to the extent permitted by the FECA. Any contribution that would otherwise cause a contributor to exceed any applicable Federal contribution limit that is not permissible under the FECA shall be refunded to the contributor. Any contributor may designate his or her contribution to a specific participating Committee, to the extent permissible by the FECA. Any contributor may make his or her contribution payable directly to any of the participating Committees listed in the Preamble to this Notice. Any such designated contribution that causes the contributor to exceed the contributor limit to the designated participating Committee shall not be reallocated by Lynn Jenkins Kansas Trust absent the prior written permission of the contributor as required by law.

Contributions to Lynn Jenkins Kansas trust are not deductible as charitable contributions for Federal income tax purposes. All funds received in response to this solicitation will be subject to federal contribution limits and prohibitions. Contributions from corporations, foreign nationals (without “green cards”), and federal contractors are prohibited.

The maximum an individual may contribute to this joint fundraising committee is \$59,300 per calendar year. Individuals should review their personal contribution histories to determine how this contribution may affect their federal individual biennial contribution limit for the 2007-2008 election cycle. The maximum amount a federal multi-candidate political action committee may contribute to this joint fundraising committee is \$35,000 per calendar year. The maximum amount a federal political action committee that is not a multi-candidate committee may contribute to this joint fundraising committee is \$59,300 per calendar year.

Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation, and employer of each individual who contributes over \$200 in an election cycle (for Lynn Jenkins for Congress) or in a calendar year (for the RNC and the NRCC).

LYNN JENKINS, A SIXTH GENERATION KANSAN, WAS BORN AND RAISED ON A DAIRY FARM NEAR HOLTON. JENKINS SPENT 20 YEARS AS A CERTIFIED PUBLIC ACCOUNTANT BEFORE SPENDING FOUR YEARS IN THE KANSAS LEGISLATURE WHERE SHE SERVED IN BOTH THE HOUSE AND THE SENATE.

IN 2002, JENKINS WAS ELECTED THE 37TH TREASURER OF THE STATE OF KANSAS. JENKINS WON RE-ELECTION IN 2006 WITH OVER SIXTY PERCENT OF THE VOTE. DURING HER SIX YEARS AS TREASURER, JENKINS HAS LOOKED OUT FOR THE FISCAL WELL-BEING OF THE PEOPLE OF KANSAS.

LYNN AND HER HUSBAND SCOTT HAVE BEEN MARRIED 25 YEARS AND HAVE TWO CHILDREN: HAYLEY AND HAYDEN. THEY CURRENTLY RESIDE IN TOPEKA.
